

Perth and Darwin have been the standout cities for capital gains over the past decade

- ▶ Capital city property values have increased at an average annual rate of 4.3% over the ten years to August 2013.
- ▶ Sydney is the only capital city to have recorded average annual growth of less than 4.0% over the past decade.
